1 Purpose of Report and Executive Summary

1.1 This report sets out changes to the Political Balance and Committee Seat Allocations and memberships as a result of a recent by-election and changes to the membership of political groups.

2 Background

- 2.1 Section 15 of the Local Government and Housing Act 1989 requires Local Authorities to review the allocation of seats on Committees at the annual meeting, or as soon as possible after it. Once the Council has agreed the allocation of Committee places between the political groups the Council must then appoint the nominees of the political groups to the Committees. This was last agreed at Council in January 2025 (Appendix I).
- 2.2 Where changes to the membership of political groups take place between elections, the Local Government (Committees and Political Groups) Regulations 1990 require the Council to recalculate the political balance and the allocation of committee seats 'as soon as practicable' after notice of changes to groups is delivered to the proper officer.
- 2.3 Due to a recent changes in political groups, the political balance has been recalculated as set out in Appendix II.
- 2.4 The following principles apply to the allocation of seats:

- (a) That not all seats on the body to which appointments are being made are allocated to the same political group;
- (b) That the majority of seats on each Committee is allocated to a particular group if the number of persons belong to that group is a majority of the authority's membership:
- (c) Subject to (a) and (b), that, when allocating seats to a political group, the total number of their seats across all the ordinary committees of the Council, must reflect their proportion of the authority's membership; and
- (d) Subject to (a) and (c), that the number of seats on each Committee is as far as possible in proportion to the group's membership of the authority.
- 2.5 There are 134 seats to be allocated under the Committee System. The seat entitlement of each group, on each Committee is thus based on the group's percentage representation on the Council as detailed in Appendix II. Whilst an initial version of this can be calculated mathematically, this usually results in a discrepancy between the strict entitlement of each group and the overall number of Committee seats to be allocated, requiring 'manual' adjustment to ensure that the number seats allocated to each group is fair.
- 2.6 To ensure overall political balance Members must negotiate with each in order that Committees are not over or under-subscribed.
- 2.7 The overall requirement for total places to be balanced only applies to ordinary committees so sub-committee places do not need to be included in the overall calculation, but the membership of sub-committee places should be proportionate as far as is reasonably practical.
- 2.8 The Joint Transportation Board and the Planning and Transportation Policy Working Group are not committees covered by Section 101 of the Local Government Act 1972 and Section 15 of the Local Government Housing Act does not apply. The membership of the Planning and Transportation Policy Working Group was determined by the Policy and Resources Committee at its June 2024 meeting and will be determined at the first Policy and Resources Committee following Annual Council.
- 2.9 Group Leaders have been requested to provide nominations to the places on Committees to which their respective groups are entitled; this has resulted in over allocations and under allocations across various committees. In addition, as there are two groups with identical membership numbers, and an odd number of seats assigned, it will be necessary for those two groups to either agree who will give the additional seat up or use a tried and tested method at the meeting to award the additional seat. The outcome of who is to give up the additional seat may impact on other groups allocations.
- 2.10 Members are able to agree a position that does not reflect the strict apportionment of political balance, but is has to be published in advance and agreed unanimously to be formally adopted. An illustrative example of this type of allocation is included in Appendix II.

3 Proposals

3.1 That Council is asked to agree the political balance calculation from the possible options as set out in Appendix II or an unanimously agreed alternative.

4 Alternative Options

4.1 In view of changes to the membership of political groups, there is no lawful alternative to the recalculation of political balance but if Members wish to propose an alternative to allocate committee seats, they may do so.

5 Consultation Undertaken or Proposed

5.1 All Group Leaders have been asked to advise Democratic Services of their nominations to seats on Committees for their respective Groups.

Groups will need to negotiate with each other on amending the allocation of seats. Rounded allocation is the rounding per committee

Round adjustment is the rounding per committee and may not give the correct total entitlement for each party which is subject to negoatiation between groups as the rounded figure gives a total of 135 seats and there are only 134 seats available

Transfe equired shows the adjustment required for Lib Dems and Reform to allocate 2 seats each to SIA across P&R/Community & Leisure/Economy & Property/Environment & Climate Change/Housing and Health/Licensing

Usually (party with the lowest proportion of a seat overall have to give up a seat (highlighted above in yellow) for each committee, however we have 2 parties with identical allocations with the lowest proportion and so they need to decide who will lose a seat. In the event that a decision is not achieved then lots will be drawn.

Lib Dems and Reform will need to allocate an additional seat (subject to lots being drawn) to the Conservative Group

Once all adjustments are included the proposed allocation should add up to 134 seats and will form the proposal to council

Individual Members may not sit on both the Investigation and Disciplinary Sub-Committee and Statutory Officers Disciplinary Appeals Sub-Committee.

Committees can establish Sub-Committees during the course of the year, with the number of members determined by the parent Committee.

As long as the membership of the Sub-Committees is broadly balanced, the total entitlement of seats will be unaffected. This will also apply to the Swale Rainbow Homes Shareholder Representation Sub-Committee, the membership of which is to be determined by the Housing and Health Committee.
