LICENSING SUB-COMMITTEE

30 NOTIFICATION OF CHAIRMAN AND OUTLINE OF PROCEDURE

The Chairman opened the meeting by introducing the Sub-Committee and asked officers to introduce themselves.

31 DECLARATIONS OF INTEREST

No interests were declared.

32 EXCLUSION OF PRESS AND PUBLIC

Resolved:

33 REVIEW OF HACKNEY CARRIAGE DRIVERS LICENCE

The Licensing Officer introduced the report which sought to consider whether the Respondent, who had accumulated a total of seventeen (17) Swale penalty points on thier Swale Taxi driver's licence. The Licensing Officer explained that a driver could have up to 11 Swale penalty points, but as soon as a driver reached 12 or more penalty points, the driver was brough to the Licensing Sub-Committee.

The Licensing Officer detailed the incidents at which the Respondent had accumulated 17 penalty points, as below:

- Twelve points for driving a hackney carriage without a hackney carriage drivers' licence; and
- five points for a failure to notify the Council of any amendment to the details of a licence within fourteen days.

The Chairman asked the Respondent to present their case, and they were asked questions.

Members of the Sub-Committee adjourned at 11:50 am to make their decision.

Members of the Sub-Committee, the Contentious Team Leader and the Democratic Services Officer returned to the meeting at 12:15 am and the decision, attached as Appendix I to these minutes was announced.

Resolved:

(1) That the Respondent's Swale Dual Taxi Driver's Licence not be suspended, but a warning be given to the Respondent.
