Kent County Council Community Services Consultation

Kent County Council (KCC) has launched a public consultation on its Community Services which runs from 17 January to 26 March 2023.

The consultation proposes changes to the way we use our buildings to deliver some of our community services. We invite your feedback on our proposals as part of this consultation.

Why are we proposing changes?

The Council has experienced big increases in costs and has less money to spend. So we need to look ahead and do things differently to make sure we can still help residents in the years to come. Whilst ensuring effective support for residents who need our services, we need to:

- tackle the rising costs of maintaining our many buildings
- find savings, so we can balance the budget
- reduce our carbon footprint to meet our Net-Zero ambitions.

What services are included in the proposals?

Children's Centres and Youth Hubs, Public Health Services for Children and Families, Community Services for Adults with Learning Disabilities, Community Learning and Skills, and Gateways.

What are we proposing?

- Having fewer permanent buildings, meaning that some of our buildings would close we want to keep buildings in areas where they are needed the most
- Co-locating more of our services, meaning more than one service would be available from some of the buildings you might visit
- Continuing to deliver some services by outreach, which means they do not take place in a
 dedicated or permanent space, but move around to when and where they are needed
- Ensuring residents can continue to access services and information online.

Our proposals have been designed by considering where there is greatest need for our services.

1.	Coach Parking	Jenny Hurkett from the Criterion at Blue Town raised the matter of coach parking on the Isle of Sheppey.	A report will be taken to Community Committee in March 2023.
		Owing to issues outside SBC's control, this matter could not currently be progressed but when feedback was received, any decision making would go to the Community Committee.	
		The Head of Environment & Leisure advised reservations were recorded on the conversion of the Ship on Shore car park for coach parking. Officers are currently revisiting the options and will come back to March 2023 Community Committee.	
2.	Connectivity across Sheppey	A question was asked at the June 2021 meeting about transport issues on the Island. The Quality Bus Partnership has been suspended while (Kent County Council) KCC look at how to set up an Enhanced Partnership which will replace the QBP.	KCC have still not received notification from the DFT that the indicative funding amount awarded will be confirmed. As such they are unable to start
		The Director of Regeneration and Neighbourhoods advised that the Kent County Council (KCC) Enhanced Partnership was still being formed. It would oversee the Countywide bus improvement plan. Although Government funding had been allocated, it had not yet been received. It was hoped that when more was known in the New Year, the Sheppey Area Committee would be able to link into any local issues.	work on any initiatives that require funding.
3.	Dumping of spoil on the Eastchurch shoreline	KCC Councillor Andy Booth asked if a report could be brought back to a future Sheppey Area Committee meeting providing details about the spoil that has been dumped on the Eastchurch shoreline. He said that it was important that the public were aware of what was happening.	The multi-agency group continue to explore possible options for action led by the Environment Agency.

4.	Replacement of lighting along Sheerness Promenade	The Area Committee awarded £8,048.74 of funding for the replacement of lighting along Sheerness Promenade. The Head of Environment and Leisure advised these are part of the LED upgrade works. The latest quote was around £186,000 so our budget of £70k plus the £8k from Sheppey area committee is not enough. The work has been split into phases and the lights for Sheppey are included in Phase 1.	A total of 9 replacement streetlights have now been installed along the Sheerness Promenade, spread out from Tesco's to Neptune Terrace, to provide lighting in the most sensitive areas such as steps and ramps.
		The Head of Environment and Leisure advised that the supply to the units was in place and final checks were being carried out. It was unlikely that all lights would be reinstated but there would be a good spread. The intention was to complete that part of the project by May 2023.	The total cost of the completed work is £14,150, funded with the Area Committee award plus part of the £70k budget.
5.	Coastal Policies Group	Councillor Peter MacDonald asked what progress had been made by the Coastal Policies Group regarding the change from no intervention on erosion to one of protection. The Director of Regeneration & Neighbourhoods advised a meeting between stakeholders and officers to progress this matter had taken place. 12.	Trinity Road, Sheerness parking	Members of the public spoke about the problems residents were having with parking in Trinity Road, Sheerness, where they had to pay for parking permits. They also asked about Marine Parade Car Park which was free to park in but due to some of the vehicles permanently parked there, residents did not feel safe to use that car park. Currently there was no clarity about the rules and some residents had received penalty notices. The Head of Environment and Leisure confirmed that the local Ward Member had raised the issue with him and the residents could park in the Trinity Road Car Park whilst an investigation was carried out into the historic agreement. The penalty notices would be put on hold until the matter was resolved.	The investigation has concluded and officers will be in contact with residents soon. Thank you to everyone who has continued to provide input and support for active travel on Sheppey.

The Sheppey Active Travel Fund Tranche 4 proposals were submitted to Kent County Council, competing with 87 other schemes. The Sheppey proposals made the initial cut to a Medium List, but unfortunately didn't make the Short List.

Active Travel Fund Tranche 4 was finally officially announced on Sunday 5th February, some five months later than expected and very different from the funding previewed in July 2022. Tranche 4 is no longer a £470m capital and £250m revenue multi-year fund, but a one year £200m construction fund. At this point, Swale Borough Council still has one bid in the process.

On 8th February, we received confirmation that Swale Borough Council has been awarded £40,000 from the Active Travel Capability Fund 2022/23. £15,000 of which is specified to "assist with the Scheme Planning and Design of Sheerness – Minster area improvements".

This funding is considered to be early feasibility stage design of schemes, to the point of bidding for capital funds, including early plans sufficient for bid stage assurance against Active Travel England design tools. This project will be commissioned as soon as possible to ensure that we have the evidence for the next tranche of Active Travel Funding.
