1 Purpose of Report and Executive Summary

1.1 The report advises Members of an application for a premises licence to be granted under the Licensing Act 2003 in respect of which representations have been made by eight (8) interested parties

2 Background

- 2.1 The Licensing Sub-Committee is asked to determine an application for the grant of a new premises licence under the Licensing Act 2003 in respect of premises at The Little Blue Hut, Queenborough Harbour, South Street, Queenborough, Kent ME11 5AF
- 2.2 The Licensing Act 2003 (the 2003 Act) requires the Council (as licensing authority) to carry out its various functions so as to promote the following four licensing objectives:
 - the prevention of crime and disorder
 - the protection of public safety
 - the prevention of public nuisance
 - the protection of children from harm
- 2.3 The 2003 Act requires the council to publish a 'Statement of Licensing Policy' that sets out the policies the council will generally apply to promote the licensing objectives when making decisions on applications made under the Act. The council first adopted its Statement of Licensing Policy in 2004 and it has been regularly reviewed in line with legislative requirements ever since. The latest

- policy was adopted on 1 April 2021. The Policy will be available at the meeting for reference purposes.
- 2.4 Under the 2003 Act, licensing authorities must, in carrying out their functions, have regard to guidance issued by the Secretary of State under section 182. The Guidance cannot anticipate every possible scenario or set of circumstances that may arise. Provided that the licensing authority has properly understood and considered the Guidance, it may depart from it when it has reason to do so. However, as the licensing authority is under a duty to have regard to the Guidance, it will need to give full reasons for any departure from it. This would be a key consideration for the courts should departure from the Guidance result in a determination which gives right to an appeal or judicial review. The Guidance will be available at the meeting for reference purposes.
- 2.5 A copy of the council's approved procedure for hearings of the Licensing Sub-Committee in relation to an application, along with a copy of the Hearings Regulations has been circulated to all parties prior to the meeting.
- 2.6 The Licensing Authority must, under the Act, refer any application for hearing to the Licensing Sub-Committee where relevant representations are made by a responsible authority or an interested party.
- 2.7 The Licensing Sub-Committee is reminded that the Human Rights Act 1998 guarantees the right to a fair hearing for all parties in the determination of their civil rights. The Act also provides for the protection of property which may include licences in existence and the protection of private and family life.

3 The Application

- 3.1 On 14th August 2022 an application was received from Ms Caroline Kennedy for the grant of a premises licence under section 17 of the Licensing Act 2003.
- 3.2 The application is for:
 Sale of Alcohol (on the premises)
 Friday Sunday 10:00 20:00
 - Also 10:00 20:00 on all bank and public holidays, Valentine's Day, Mother's Day, Father's Day, Christmas Eve and New Year's Eve and on days when Queenborough Market is operated on Queenborough Harbour
- 3.3 Part M of the statutory application form asks applicants to describe the steps they intend to take to promote the four licensing objectives. Where an application has been properly made and no responsible authority or other person has made a relevant representation, or where representations are made and subsequently withdrawn, these proposals are 'converted' in the form of clear and enforceable

- licence conditions which, together with the Mandatory Conditions, make up the premises licence.
- 3.4 A copy of the application is shown as **Appendix I.** A copy of the plan for the premises are shown at **Appendix II.** Photos of the premises are shown as **Appendix III.**
- 3.5 Permission to use the premises for the sale of alcohol has been obtained from Queenborough Harbour Trust as shown at **Appendix IV**.

4 Representations

- 4.1 At any stage during the 28 day consultation period a responsible authority, a Councillor or an interested party, may make representations provided that the grounds are relevant to the licensing objectives and are not deemed to be vexatious, frivolous or repetitive.
- 4.2 Representations from responsible authorities:
 - Kent and Medway Fire and Rescue Service No representations.
 - Kent County Council Trading Standards No representations
 - Kent County Council Services Children and Families No representations
 - Kent County Council Public Health No representations
 - Environmental Health, Swale BC No representations
 - Swale Borough Council Planning Area Team No representations
 - Kent Police Have requested conditions as shown below:
 - All persons that sell or supply alcohol to customers must have licensing training
 - 2. Training should take place within six weeks of employment and any new employees will be supervised until the training has taken place
 - a) Refresher training should be repeated a minimum of every six months or earlier if required due to changes of legislation
 - b) Training records must be kept and shall contain the nature, content, and frequency of all training
 - Records must be made available for inspection by Police, Police Licensing Officer, and authorised officers from the Local Authority upon request either electronically or hard copy
 - 3. A challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as driving licence, passport, military ID card or proof of age card with the PASS Hologram.

- 4. After close of business, staff will clear any rubbish that has been left within the licensable area of this premises licence.
- 4.3 There have been eight (8) representations from members of the public. The representations are made on the basis of all 4 of the licensing objectives of prevention of crime and disorder, promotion of public safety, prevention of public nuisance, and protection of children from harm. These are shown at **Appendix V.**







We would like to object to the licence application in respect of the "Little Blue Hut", at Queenborough Harbour, South Street Queenborough.

There are several reasons for this objection and these are set out below.

The behaviour to date of the licensees - These premises used to be a small hut selling fish run by the local fishermen. It had only been there for a couple of years but was quiet and unobtrusive. The hut is not a permanent structure and has no water or drainage, and the electricity supply is a makeshift cable laid across the harbour connected to a 16A marine supply. In June this was taken over by a local pub landlord and suddenly became a real problem. Chairs all over the quay and drunken people abusing residents particularly those swimming and doing watersports. The biggest problem was that actually the premises was not licensed and it was open every Friday, Saturday and Sunday throughout June, July and August. Apparently they were relying on the licence of the pub but this should not have allowed them to open for 13 weeks 3 times a week totalling 39 occasions. They have told us they fully intend to continue opening on these days until they get a permanent licence, and they continue to advertise this on billboards in South Street. So they clearly have absolutely no respect for the licensing laws or the licensing authority. They have though provided an opportunity for local residents to see exactly what it would be like if they were open permanently.

ASB-this is an area with very significant antisocial behaviour and this really only started in June when these premises became licensed. The police have to patrol every weekend because of groups of young people congregating on the quay, smoking and drinking, damaging fishermen's properties and boats. The last thing this area needs is this licensed premises which has no indoor space and simply encourages people to sit around on the quay drinking and adding to, if not causing, the problems for the local residents and the police.

Noise-these premises have no indoor space so all of the people drinking and all of the music would be outdoors. They are just a few metres from residential properties and this would cause (and is already causing) significant noise nuisance for those residents most of whom have their small gardens at the back of the properties directly opposite the fisherman's hut. They can no longer sitting there little gardens on a weekend afternoon because of the noise.

Safety-this small hut is on the edge of the quay literally 2 m from the edge. There are no barriers along the edge of the quay and the water is very deep. There is a significant drop into the water and this is the last place that you want to have people who are drinking alcohol. Also they are already making it dangerous for people walking along the edge of the quay because they are making the walkway so narrow because they have so many tables and chairs. It is impossible to walk safely along the quay and people are forced to walk in the road which is dangerous in itself. Added to this there is a lot of fisherman's equipment in this area because it is right by where the fishing boats leave from. Having people drinking, music and so on right by all the fishing equipment would itself be an added danger.

Queenborough quay used to be a quiet place for people to sit and contemplate the harbour. This year it has become a magnet for ASB and for people sitting on tables and chairs all over the place drinking alcohol and on occasions having musical entertainment. This is completely inappropriate for this area, it is adding to the ASB and it is already causing safety issues for people using the hut but also local residents who just want to walk along the harbour/quay. This is the last place that we want licensed premises and there are plenty of pubs in Queenborough for people to go to and we do not want an outdoor pub in the middle of a residential area on the edge of deep water.

I have been trying to establish how to object to an extension of an alcohol license namely at the fresh fish shed on the quay at Queenborough creek, can you advise how I can do this as I am unable to locate this on the SBC webpage.

If time is running out please note my objections as the proposed bar is close to the water which inhibits walking and therefore a danger to those using the area and walking by. Queenborough is a marine conservation area and the extension would cause more disruption to wildlife particularly the seal family who go into this creek area. The noise would disrupt local homes and local water users, People drinking so close to the water could be in danger as there is not adequate guards to the deep drip into the creek and this cannot be blocked as would inhibit local water users and fishermen accessing their boats. There are no toilet facilities so there is the potential for urination in alleys etc. There is very little room where this shed is located and so would block access for users (as it does now but only some days) and the blocking would mean reducing the walk way and therefore people drinking alcohol would be close to the sea a dangerous combination.

This trend has made life for residents miserable. The Rose in particular is now encouraging private parties with music in the evenings. We are in a conservation area and even if we could shut our windows in this hot weather, the noise is still like having a disco right outside as we cannot have double glazing on our property.

Coupled with the direct problem of noise is the lack of parking space and noise of people leaving events.

We have a number of establishments selling alcohol in the area, namely Queen Phillipa, The Rose, Flying Dutchman, Admirals Walk Micro pub, Yacht Club and Old House at home. All are playing music loudly and all are in and around the high street in Queenborough. We have 6 and do not need another place that sells alcohol that plays loud music!

This hut is right next to the creek, there is no running water for hygiene purposes, no bins that I can see ~(I saw a man who was standing there drinking and threw his cigarette butt into the creek). We do not need people throwing their rubbish in the water. We have seals that swim up the creek from time to time and residents should not have to put up with pollution from rubbish being dumped into the creek. Anti-social behaviour is on the rise in Queenborough and as you well know, with the creek area being a hot spot, do we really need to fuel this with even more alcohol. We only had to listen to the residents at the public meeting to see that. Even today people where walking up and down south street with pints of beer, which was not acceptable.

24 hours after the queen, died loud music from the Dutchman again this was reported to noise enforcement, I know that you will say this allowed but sorry there is no respect for the residents, and how do we know the blue hut will not go the same way, as it is how's has been operating for the past months selling alcohol?

I am writing to object to the licence application of the Little Blue Hut at the Queenborough Creek, South Street. I wasn't going to bother writing to you as I know that the license will be given regardless of objections. I was also not sure that highlighting our current issues that we already have in Queenborough with the public house situation (the noise, loud music that goes on way after 10pm, brutal fights, issues parking etc.), although we cannot escape them as residents, are not wholly the Flying Dutchman's doing. Caroline also wanted to reassure me that the music and drinking at the little blue hut would be kept low key. However, upon thinking further about the safety of the people drinking there and the surrounding dangers that present themselves for anyone under the influence of alcohol, I don't think it is a suitable venue. I know it can be argued that there are public houses dotted all over Queenborough and the risk is still there but having the hut so close to the creek simply puts potential dangers closer. People could either drown in the water, fall on the concrete berths, or get stuck in the mud on a fast tide.

I also wondered where the patrons would go if they needed to relieve themselves — as often people do if they've had a drink of alcohol — and Caroline assured me that they could go to the Flying Dutchman toilets. The Flying Dutchman is quite a walk from the little blue hut (about 3 minutes) with an alley between houses to access the High Street where the pub is located. I believe that some males will be tempted to relieve themselves in the alley or in the creek instead of walking three minutes to go to the loo (which could cause issues with children potentially seeing this behaviour — in terms of safeguarding and thinking it is acceptable behaviour). There will also be disturbance to residents on the high street with people walking between the Dutchman and the little blue hut to use the toilets. I also worry about the amount of litter and cigarette ends which may end in the creek from this venture. But I suppose licencing don't need to have any consideration for this or any other consequences of having yet another drinking establishment in Queenborough.

I appreciate that someone wants to branch out and increase their profits, build their business etc. but having heard the loud music last night that went on until 23:15 at the Flying Dutchman for a wedding – it reminded me that there seems to be little respect for the neighbouring residents if this gets in the way of making profit. We seem to be stuck between five public houses, some wanting to play loud music until late, some where people are drinking outside making noise, littering the beach with either glass or plastic, and we cannot escape the noise. So, I feel like I'm given no

choice than to voice my opinion and raise my concerns knowing that they will be discarded on the pile of other correspondence of concern.

The latest announcement on social media that the Flying Dutchman will be offering themselves as a wedding venue fills me with dread if last night is anything to go by. I was under the impression that the Aviator was becoming a wedding venue, making good sense because there is ample parking and no neighbours to consider.

I feel I've still wasted half an hour of my life writing this in vain.
