Sittingbourne Area Committee: Progress on matters arising – February 2025

No.	Item	Background	Actions/updates
1.	Heritage issues	Area of Special Control of Advertisements (ASCA) Swale Borough Council currently does not have an ASCA. Since the adoption of the Heritage Strategy in 2020 and subsequent Action Plans wherein a number of Conservation Areas have been reviewed, it has been proposed that in order to better manage and maintain Swale's historic environment and heritage, a borough wide ASCA can prove beneficial. Any designation needs to be based on public consultation and must follow specific legal steps, including consideration of the order by the Secretary of State. Following an all members briefing in May 2024, it was agreed that a draft consultation document be prepared for approval by the Planning Committee, before undertaking public consultation.	The draft consultation document is estimated to be ready by spring/early summer 2025.
2.	Periwinkle Mill	Updates have been given at previous meetings on Periwinkle Mill.	Works have commenced with site clearance, initial tidying up around the wheel and laying some of basic hard landscaping. Safety features including grates and rails have been manufactured with installation taking place imminently. Additional works above those planned are required on the flooring.

			It is currently anticipated that works will completed towards the end of March, with some soft landscaping potentially extending beyond this.
3.	Swale Local Heritage List	Updates have been given at previous meetings on the Swale Local Heritage List.	The Selection Panel met on 17 October 2024; 278 nominations were presented out of which 150 were shortlisted to be designated as Swale's Local Heritage.
			The proposed designation list was presented to the Policy & Resources Committee on 27 November 2024, wherein it was unanimously agreed to designate the shortlisted assets with addition of one more asset - taking the total to 151 designated assets on Local Heritage List. The mapping work on SBC GIS system and associated data organisation that will include photo and brief description of each asset is ongoing.
			At the Selection Panel meeting there were several deferrals. Also, a few geographical gaps have been identified in terms of current nominations and there is a desire to include recommendations emerging from Conservation Area appraisal work. As such, an additional call for Local Heritage assets will be run early summer 2025, with the Selection Panel meeting again in the autumn of 2025. Following that, it is anticipated the list would be updated every three years following a call for nominations and Selection Panel. The next one being scheduled for 2028.

Transport issues	 Members discussed the difficulties residents were experiencing with bus services in Swale and agreed the following actions: 1) Invite the bus companies and a representative from Southeastern Trains to come along to a future Sittingbourne Area Committee meeting; 2) The Chair would write to Kent County Council (KCC) to find out when the Government Funding allocated to improve bus services would be activated in Swale; and 	Members will provide a verbal update at the meeting.

APPENDIX 1

UK Shared Prosperity Fund (UKSPF) and Rural England Prosperity Fund (REPF) Update Sittingbourne Area Committee February 2025

The current UKSPF programme runs from April 2022 to March 2025, and the REPF programme commenced in April 2023 and concludes in March 2025. The programme is split into 3 priorities, and a further priority for REPF. The projects in the programme are listed below with the latest update:

Community and Place

- Town Centre Radio Scheme completed. Linking town businesses with CCTV in Sheerness, Faversham, Sittingbourne and Leysdown.
- Town Centre Action Plans/Grants ongoing. Open competition for grants of up to £10,000, for community focused projects. In Sittingbourne, projects which received funding include:
 - Remembrance Event 2023 (Historical Research Group of Sittingbourne); floral displays in Milton High Street (Milton Regis Society); Sittingbourne Carnival 2024; Swale Media Arts Centre exhibition; paper making workshops in the Forum Shopping Centre (AMTeC Heritage Science CIC); The Sick Dolls, Toys and Books Clinic (Sittingbourne Heritage Museum)
 - Lift at the Avenue Theatre to improve accessibility; refurbishment of public toilet at Swale Community and Voluntary Services (CVS), new CCTV in Milton Regis, and Swale Wassail high street event organised by AMTeC Heritage Science CIC.
- Faversham Town Centre Capital Project ongoing. Wayfinding investment for the town.
- Sittingbourne Town Centre Capital Project ongoing. The restoration of and creation of a public space at Periwinkle Mill.
- Isle of Sheppey Capital Project ongoing. Trinity Gardens improvements and feasibility work for the Old Library.
- Sheerness Levelling up Fund support ongoing. Work at Beachfields as part of Sheerness Revival Project.
- Community Infrastructure Grants for community facilities (also funded through the REPF) – ongoing. Small capital grants scheme to support community facilities with carbon reduction measures and digital connectivity. In Sittingbourne, funded projects include:
 - Community Hub "Space in the Park" at Milton Creek Country Park; amenity enhancements at Murston Old Church (Murston All Saints Trust); paving and accessibility improvements at Sittingbourne and Kemsley Light Railway.
 - Contribution towards the refurbishment of Heather House Community Centre (applications from SATEDA, Swale Community Care Project, Age UK Kent Rivers); and creation of a new sanctuary space at New Leaf Support.





- Capacity building the CVS in Swale ongoing. Working with local civil society organisations to improve capacity and efficiency through improved collaboration.
- TS Hazard feasibility work ongoing. Study to explore feasibility of community operation of building

Support for business

- Community business support Pilot to introduce specialist support for the development of community run businesses in Great Easthall, Sittingbourne.
- Market feasibility work Feasibility work to look at the markets in the Borough and how they can be developed for the future.
- Visit Swale photo/video ongoing. Revenue investment in creating marketing materials to support the visitor economy.
- LUF Capital Support (Sheerness) ongoing. Contribution to Sheerness Revival project
 match funding for development of workshops at Masters House.

People & Skills

- Programme providing employment and skills support, digital inclusion and engaging local employers in upskilling existing staff.
- Capital Investment in an adult learning space in Swale House.

REPF

 Rural Swale Small Business Grant – ongoing. Grants to support micro and small businesses to invest in capital projects and grants for the development and promotion of the visitor economy.

The government recently announced a further allocation of £554,150 UKSPF funding for the 2025/26 financial year. The Economy and Regeneration Committee will consider the future programme on the 20 March 2025.
