1 Purpose of Report and Executive Summary

1.1 To inform Members that the AONB (Area of Outstanding Natural Beauty) Unit have updated their position in relation to NS1 SE Sittingbourne.

2 Background

- 2.1 As you will recall, a report was brought to the Local Plan Panel on 17th October 2019 titled "Second Stage Assessment of the Four New Garden Community Proposals."
- 2.2 Following the drafting of the PBA consultant assessment work based on agreed notes, the AONB unit has further clarified its position on NS1 South East (Appendix II) stating their view 'that the proposed new motorway junction, located partially within the AONB, represents a major development that would be contrary to planning policy and due to its nature, could not be satisfactorily mitigated in terms of impact on the AONB. Therefore, the Unit continues to object to the proposal."

3 Proposals

3.1 The proposal is therefore that Members note the updated advice from the AONB unit and it is attached as an amendment to the PBA report.

4 Alternative Options

4.1 Members could decide to ignore the AONB Units' updated advice and continue to rely on the previous advice and not alter the Second Stage Assessment of the Four New Garden Community Proposals Local Plan Panel report.
